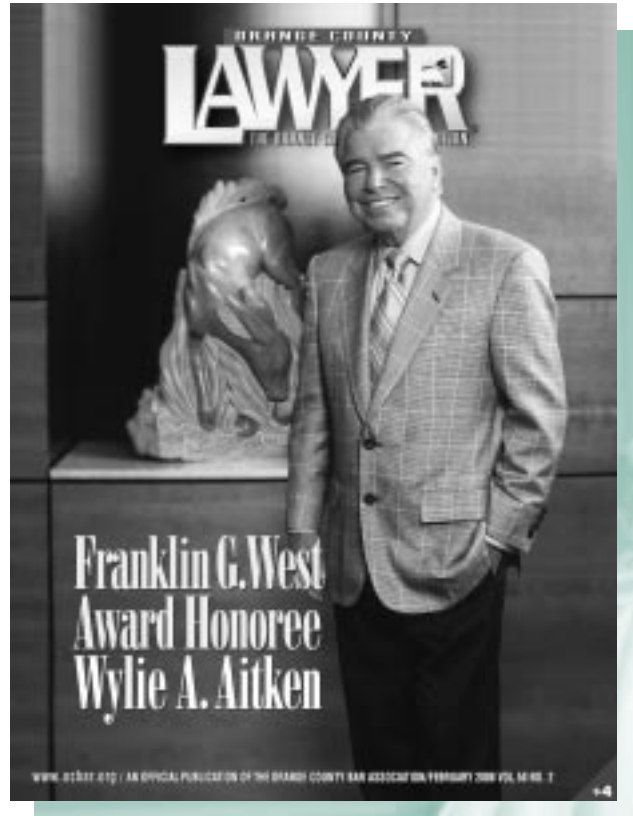

Recent poll indicates strong public support of the civil justice system

Recently, the American Association for Justice released an important poll. It showed significant anxiety concerning corporate misconduct and large support among voters for a strong civil justice system to ensure corporate accountability and fairness. Key findings reveal that...

- Americans are deeply concerned about their nation's future and believe corporate misconduct is a major source of their anxiety. Worried "swing voters," who see corporate irresponsibility as a central problem, may play a pivotal role in the 2008 election.

- Voters support the civil justice system as an important remedy for corporate misconduct, and reject legal "reforms" that restrict plaintiffs' ability to hold corporations accountable and obtain fair restitution.

- Voters will support candidates who defend the civil system over candidates who assail "frivolous lawsuits" and advocate "tort reform." Pro-civil justice candidates not only command overwhelming support from swing voters, but also appeal to significant blocks of Republicans.

RECENT CASE RESULTS

↳ **Auto vs. Auto**—The plaintiff was called to assist his son, whose vehicle had a mechanical breakdown. He arrived at the place of the breakdown and pulled his vehicle onto the shoulder, well out of the lanes of traffic. Upon determining the vehicle had to be towed, he went between the two vehicles and stood there to place a call to AAA. The intoxicated defendant driver's vehicle drifted off the roadway and violently rear-ended the plaintiff's vehicle, pushed it into the plaintiff, and propelled him onto the hood, windshield, and several feet into the air, over a chainlink fence, and down the embankment. The plaintiff sustained severe and life-changing injuries requiring multiple surgeries.

SETTLEMENT: \$6,200,000

↳ **Medical Malpractice**—The plaintiff claims for medical malpractice birth injury against the defendant hospital and doctor for negligently reading and interpreting the fetal monitor strip and prolonged partial hypoxic-ischemic encephalopathy, resulting in significant injury and damages due to this incident, including seizure disorder and speech and behavioral delays.

SETTLEMENT: \$2,335,000

↳ **Auto vs. Pedestrian**—The plaintiff, a pedestrian, received serious injuries, including traumatic brain injury and neck, back, abdominal, and other extremity injuries (requiring surgeries), caused by the defendant driver, who negligently failed to stop his van at the limit line of the crosswalk and collided with the plaintiff, causing him to tumble onto the hood of the van and slam onto asphalt 15–20 feet down the road.

SETTLEMENT: \$3,400,000

↳ **Auto vs. Auto**—The plaintiff and his passengers were in their vehicle, traveling on I-15 Freeway, when the defendant's truck, traveling at a high rate of speed, rear-ended the plaintiff's vehicle, causing it to overturn and slide a great distance. The plaintiff driver's serious injuries required four surgeries, and the passengers received traumatic injuries to the chest, abdomen, and back.

SETTLEMENT: \$1,000,000

Home security tip
